Active in associativism, she was recently named Deputy Secretary by the Committee of E.C.C.O. the European Confederation of Organizations of Conservators-Restorers, of which it has been a member since 2015, through the Delegation of the Professional Association of Conservators-Restorers of Spain, of which it is its Vice-President and responsible for Program 5., on Visibility in the European cultural policies.

In 2015, it coordinated the Meeting of Nájera for the Spanish development of the Strategic Plan of ECCO from ACRE, achieving the ratification in 2017 of the Declaration of Nájera between the educational centers and the professional associations of the Conservation-Restoration.

It also belongs to other international organizations such as ICOM, in the IC-MEMO Museums group in memory of victims of public crimes.

Title

Challenges to the heritage professions, perspectives for the future

Abstract

The present conference has to show the process of creation of the recommendations of the MAC or open method of coordination and how it is reflected in the European institutions and the member states.

For the first time since the creation of the Culture Agenda of the European Commission in 2007, a working group of national experts has been proposed following the Open Method of Coordination, MAC, on Heritage Professions.

Integrated into the Culture Plan of the European Commission 2015-2018, the MAC "Skills, training and knowledge transfer of the Traditional and Emerging Heritage Professions", started in February 2017 and will conclude in the winter of 2018 with a Book of Recommendations integrating examples of success.

For this, three axes are proposed:

It is essential to present previously the European institutional networks that favor the creation of cultural and patrimonial policies, integrating as a novelty the non-governmental organizations in the Program of the Voices of Culture. (2015)

On the other hand, analyze the framework of action that constitutes the European Year of Cultural Heritage, with one of the four basic pillars dedicated to the competences of the heritage professions.

Finally, present the open method of coordination: its methodology, the analysis and the results of the working group to date.
